Garbage Collection Services May Change!

The City has begun preparations for bidding out the collection of garbage (Solid Waste is the correct term). The current contractor is Southwest Disposal and that contract ends June 30, 2011.

There will be some changes in the Solid Waste service due to changes in State Law. Under the new contract; any commercial unit may contract with any Licensed Hauler (Garbage collector licensed by the City of Willcox) for picking up and properly disposing of their Solid Waste.

The City is considering the possibility of having one-day-a-week pickup for residential units. The reason this is being considered is to try and reduce the cost of the service. The City will not know what the possible effect may be until after the bidding process is complete. There are pros and cons to this process and the process requires receiving approvals from the County Health Department and from the State Environmental Department.

Another change being considered is that **ANY** Person or Business, who is connected to the City's utility service, **whether inside the City or outside the City**, will be required to contract for Solid Waste services with the City.

There are some changes that affect landlords and the manner in which the rental accounts may be established. These are recommended to reduce the cost of operation; hence reduce the cost for the users of the service

The Solid Waste Fund is a service provided by the City of Willcox. The Solid Waste Fund is an Enterprise fund; no Tax dollars are used to pay for the operation. The City Council periodically reviews and sets the rates at a level which will pay for the costs of pickup, administration and disposal of the garbage; there is no "profit" or use of the monies for other City purposes.

The City is constantly looking for ways to reduce the cost of service while maintaining the quality of service.
