## **City Reviewing Natural Gas System Needs**

While some people are predicting the end of the world (because of the end of the Mayan calendar), the city is taking a different point of view and preparing for the long term ability to deliver safe and dependable supplies of natural gas to the residents and businesses within the community at the lowest possible cost.

The City has had a review done on the current gas system to look for areas which may need upgrades and improvements; the city does this for both the short term (annual improvements that we make such as replacement of old steel lines within the City) and long term (improvements that need to be made to keep the system operating, like replacing the main supply line from the El Paso supply line to the City).

The City Council is currently reviewing the capital needs of the system to decide which are the best options to consider. The City recognizes that every option has costs associated with the option. These costs have to come from the rates which our people and businesses pay for gas service (the City keeps the cost of operating the gas system separate from the other operations of the city – in a separate "fund" and only pays for operation of the gas fund from those rates).

The City also recognizes that the customer wants to have a save dependable supply of gas available when they need it. So the question becomes; what are the "best options" which will assure the customers the gas they need at the lowest cost.

We have to have programs to replace lines in the ground before they fail, detect and repair leaks, accurately and fairly charge customers for their use, and plan for the future of the gas system.

You are invited to attend the discussions, listen to the information, and give your input. The first meeting was held on October 22 at 6:30 PM at the City Council Chambers. Additional meetings will follow as the issues unfold.
