A RESOLUTION OF THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA, APPROVING AND ADOPTINGTHE PURCHASE OF REPLACEMENT COMPUTERS AND MONITORS THROUGH VALLEY TELECOM GROUP, INC. ["VTG"] PURSUANT TO AN EXISTING CONSULTANT AGREEMENT WITH THE CITY OF WILLCOX ["CITY"] AND AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION AND DECLARING AN EMERGENCY TO EXIST

- **WHEREAS,** the **CITY** is authorized pursuant to A.R.S. ' 9-240, et seq. to exercise control of the finances and property of the corporation and to appropriate money for the payment of its debts and expenses; and
- **WHEREAS**, the **CITY** is vested with all powers of incorporated towns as set forth in title 9 or other provisions of law relating to cities and towns pursuant to A.R.S. '9-499.01, et seq.; and
- WHEREAS, the CITY is authorized pursuant to the adopted Procurement Policy to obtain services for the items encompassed within the Contract; and
- WHEREAS, the CITY has an existing contract with VTG for the purpose of performing the consultant services as specified in the Scope of Work, Section 1, Paragraph (3)(a)(4); and
- **WHEREAS**, the Mayor and Council desire to have this Resolution presented at the December 19th, 2011 Council Meeting; and
- **WHEREAS**, it is necessary for the preservation of the peace, health, and safety of the City of Willcox, Cochise County, Arizona, that an emergency be declared to exist to assure timely purchase of the equipment, and that this Resolution shall be effective immediately upon its passage and adoption.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA, AS FOLLOWS:

- Section 1: That approval of the **VTG** equipment purchases as described above is in the best interests of the residents of the City of Willcox.
- Section 2: That the CITY formally approves and adopts VTG equipment purchases for the amount of \$8,876.67, by reference, as if set forth herein in full.

Section 3: That the immediate operation of the provisions of this Resolution is necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, and this Resolution shall be in full force and effect from and after its passage by the City of Willcox, Cochise County, Arizona.

Section 4: That the Mayor is authorized and empowered to execute this Resolution for the purpose of approving the **VTG** equipment purchases and is authorized to execute the Contract.
