A RESOLUTION OF THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA, APPROVING AND AUTHORIZING THE EXTENSION FOR THE DESA ARCHITECTURE CONTRACT FOR THE WILLCOX COMMUNITY CENTER IMPROVEMENTS UNDER PHASE III THAT WILL BE FUNDED UNDER CDBG CONTRACT NO: 107-09 ADMINISTERED THROUGH SEAGO AND AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION AND DECLARING AN EMERGENCY TO EXIST

WHEREAS, the CITY is authorized pursuant to A.R.S. §§ 9-240 and 9-276, to receive and distribute state and local monies which can be used for local planning and technical assistance as provided by SEAGO; and

WHEREAS, the CITY and DESA have an existing contract to perform Phase III renovations at the Willcox Community Center and the additional funding will be used to complete Phase III; and

WHEREAS, the CITY is in need of additional Phase III services from DESA to complete the renovations and desires to extend the existing contract; and

WHEREAS, DESA is agreeable to perform additional Phase III services for a sum not to exceed Three Thousand Dollars (\$3,000.00); and

WHEREAS, the Mayor and Council desire to have this Resolution presented at the December 19th, 2011 Council Meeting and have determined that approval of the **DESA** Contract Extension is in the best interest of the **CITY** and its residents; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of Willcox, Cochise County, Arizona, that an emergency be declared to exist to assure timely execution of the Contract Extension, and that this Resolution shall be effective immediately upon its passage and adoption.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF WILLCOX, COCHISE COUNTY, ARIZONA, AS FOLLOWS:

Section 1: The approval of the **DESA** Contract Extension as described above is in the best interests of the residents of the City of Willcox.

Section 2: That the **CITY** formally approves and adopts the **DESA** Contract Extension, by reference, as if set forth herein in full.

Section 3: That the immediate operation of the provisions of this Resolution is necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, and this Resolution shall be in full force and effect from and after its passage by the City of Willcox, Cochise County, Arizona.

Section 4: That the Mayor is authorized and empowered to execute this Resolution for the purpose of approving the Contract Extension and is authorized to execute the Contract Documents on behalf of the CITY.
