Economic Development to expand the City's tax base

# City can better manage the airport **than the County and not miss opportunities because of management.**

Naming rights will be transferred to the City – Willcox Municipal Airport

The Airport is in fair to good shape and the city acquires all operational assets at no cost to the City.

Airport is equipped with an established FBO.

The operational deficit is small and could be offset with minor changes in current revenue streams.

The City Council will have the ability to establish a permanent Advisory Board to assist the staff with and advise the Council on aviation related needs.

The City is effectively landlocked and it makes it difficult to expand without annexation. The Airport adds approximately 280 acres that could be developed. Adding a total of over 900 additional acres to City facilities.

The City has new management in lots of areas and things are being done now. The City is reflecting good leadership and can pass that on to the airport.

### CONS...

Why would the City want or need the airport if the County will continue to run it and fund it?

The City will be looking at a loss of \$5,000.00 to \$15,000.00 per year in operating deficit.

The City is currently in a budget crunch. They do not have the capacity to manage the airport at this time. How can they do any better then the county.

The city spending additional money on the airport creates a conflict of priorities. Such as roads not getting paved and potholes not being filled in the city.

The Airport has attached to ownership a very large and long federal commitment. What will the City do if the current FBO leaves, who would manage the day to day operations? Finding knowledgeable FBO's is very difficult and some Cities are currently having FBO staffing issues.

How can the City justify adding the expense of the Airport and not be able to give the employee's any type of cost of living allowance, yet expect them to pick up the additional work.

#### Conditions from County to be put in report to Council if so moved:

Transitional budget assistance for a determined amount of time. County will continue to share cost of revising Master plan with the City. The County will transfer title to all real and personal property to the City of Willcox. **Owning the Airport will:** 

Establish a new pro-business and development reputation for the City. Since the airport will have it's own dedicated revenue stream, City departments could add additional capacity to deliver services to the rest of the city.

The City having the airport adds additional land availability to use for development purposes and expands the City's economic opportunities. The airport could create potential educational opportunities to the community through aviation related training.

#### The following motion was moved and seconded:

The Ad-hoc Committee will recommend in a written report to the City Council that the City of Willcox should acquire the Airport from Cochise County.

No additional discussion was held and the motion carried by unanimous vote of the quorum in attendance.
